



The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 45.859% points. The greatest weakness of Schrobsdorff Holding AG is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 120.823% points.

The company's Economic Capital Ratio, given in the ranking table, is 46.521%, being 45.784% points above the market average of 737%.
