

#### HBG Bau GmbH Rank 100 of 109

The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 31% points. The greatest weakness of HBG Bau GmbH is the variable Liabilities, reducing the Economic Capital Ratio by 514% points.

The company's Economic Capital Ratio, given in the ranking table, is 108%, being 629% points below the market average of 737%.
