

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 34% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 28% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 11% points above the market average of 256%.
