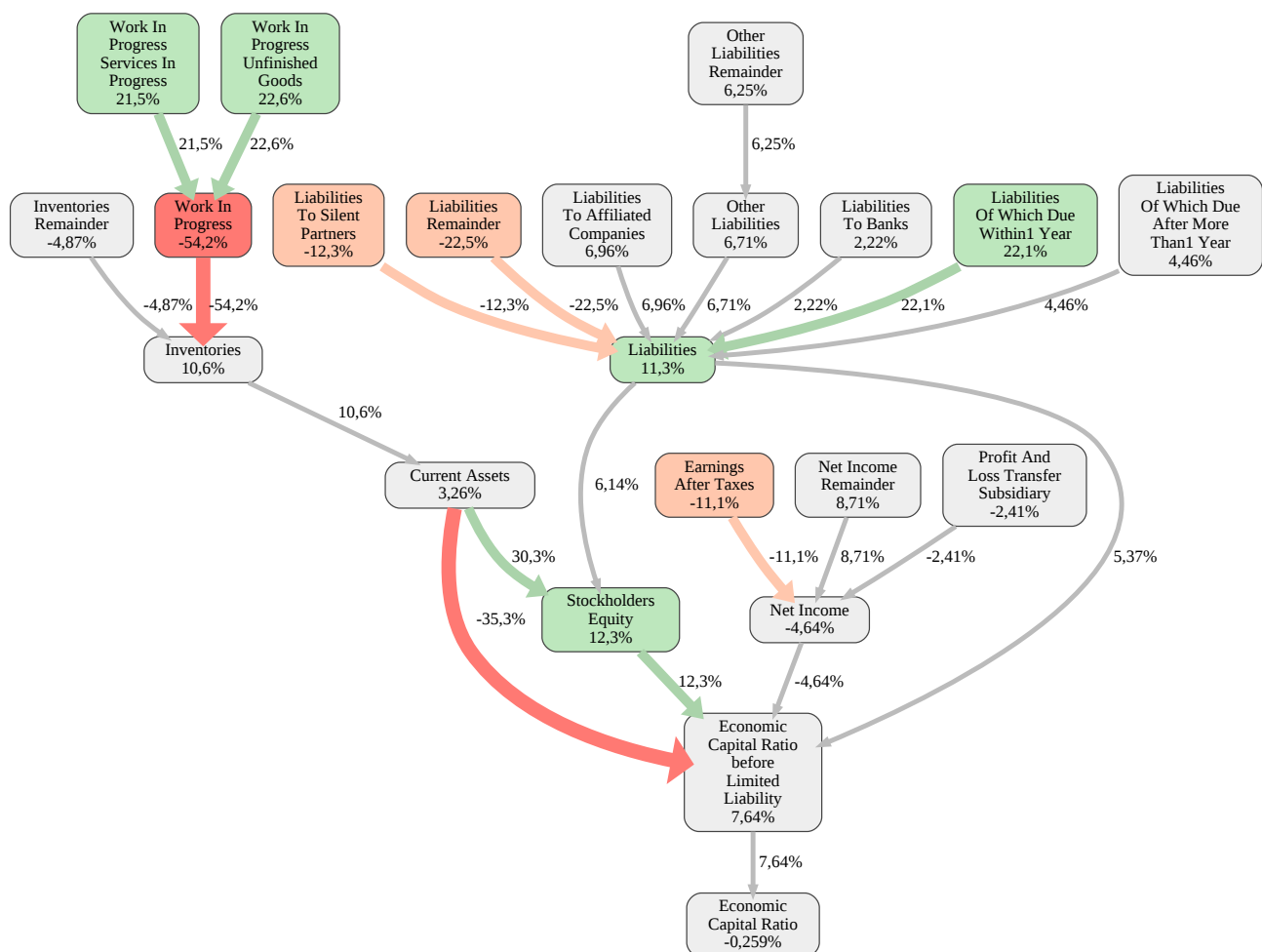




The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Work In Progress Unfinished Goods, increasing the Economic Capital Ratio by 23% points. The greatest weakness of VSTR AG Rodewisch is the variable Work In Progress, reducing the Economic Capital Ratio by 54% points.

The company's Economic Capital Ratio, given in the ranking table, is 255%, being 0,26% points below the market average of 256%.
