

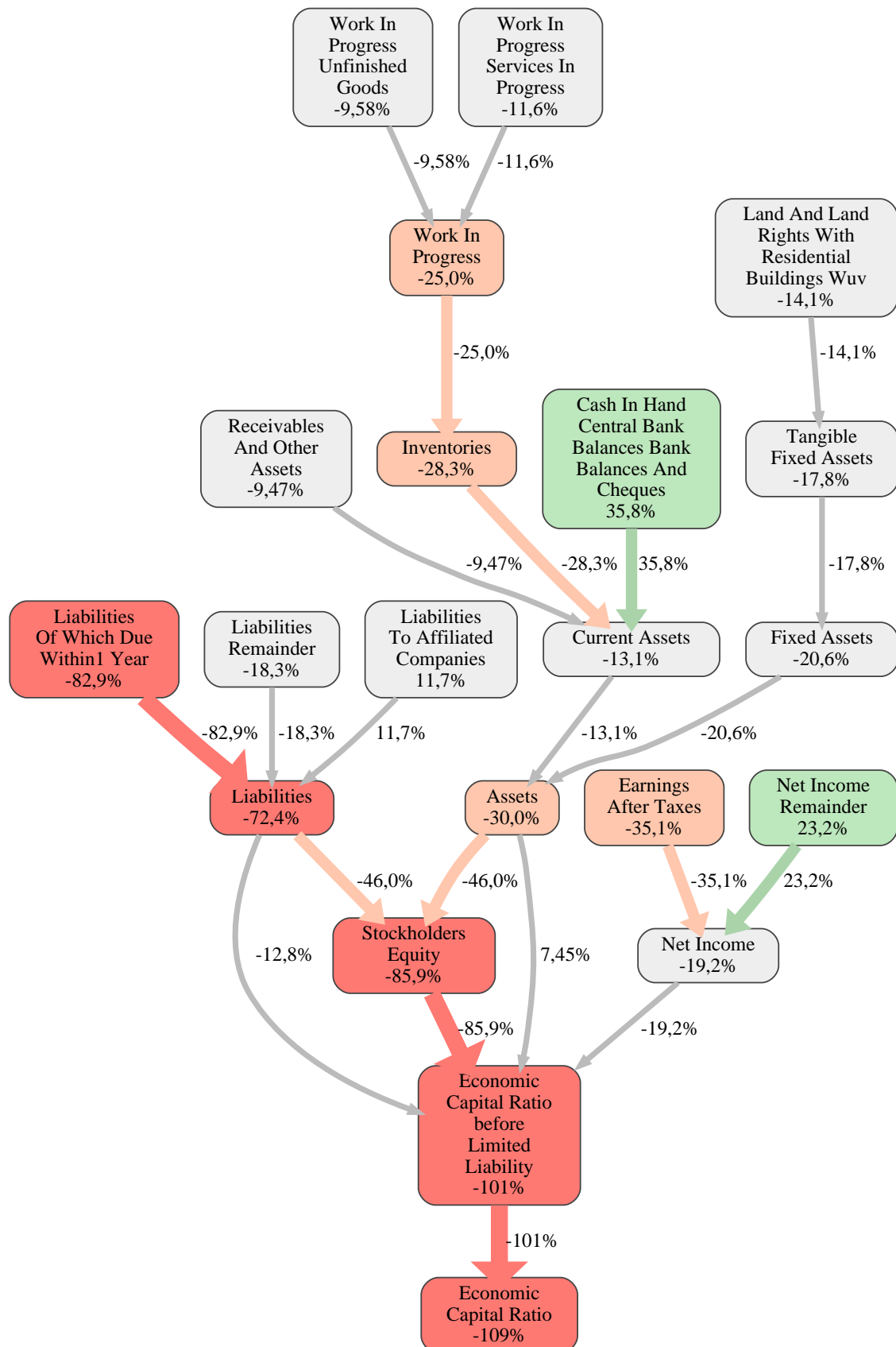

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 36% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 86% points.

The company's Economic Capital Ratio, given in the ranking table, is 147%, being 109% points below the market average of 256%.
