

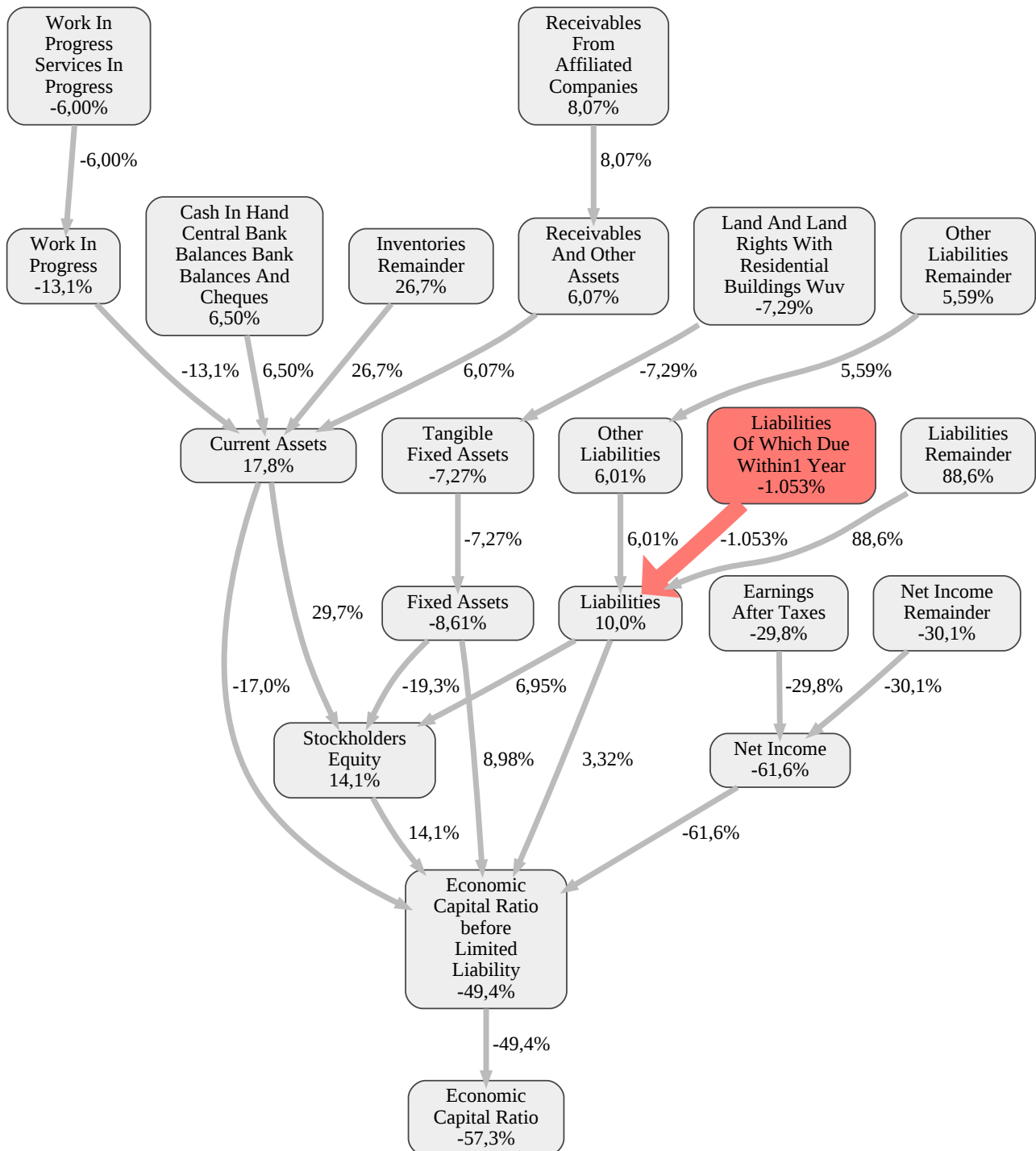

The relative strengths and weaknesses of Wolf System GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wolf System GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of Wolf System GmbH is the variable Liabilities Of Which Due Within 1 Year, reducing the Economic Capital Ratio by 1.053% points.

The company's Economic Capital Ratio, given in the ranking table, is 198%, being 57% points below the market average of 256%.
