

Rensch Haus GmbH Rank 78 of 108

The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 101% points. The greatest weakness of Rensch Haus GmbH is the variable Liabilities Of Which Due Within1 Year, reducing the Economic Capital Ratio by 322% points.

The company's Economic Capital Ratio, given in the ranking table, is 212%, being 44% points below the market average of 256%.
