

Hanova Services GmbH Rank 100 of 108

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Hanova Services GmbH is the variable Liabilities Of Which Due After More Than 1 Year, reducing the Economic Capital Ratio by 1.164% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 147% points below the market average of 256%.
