

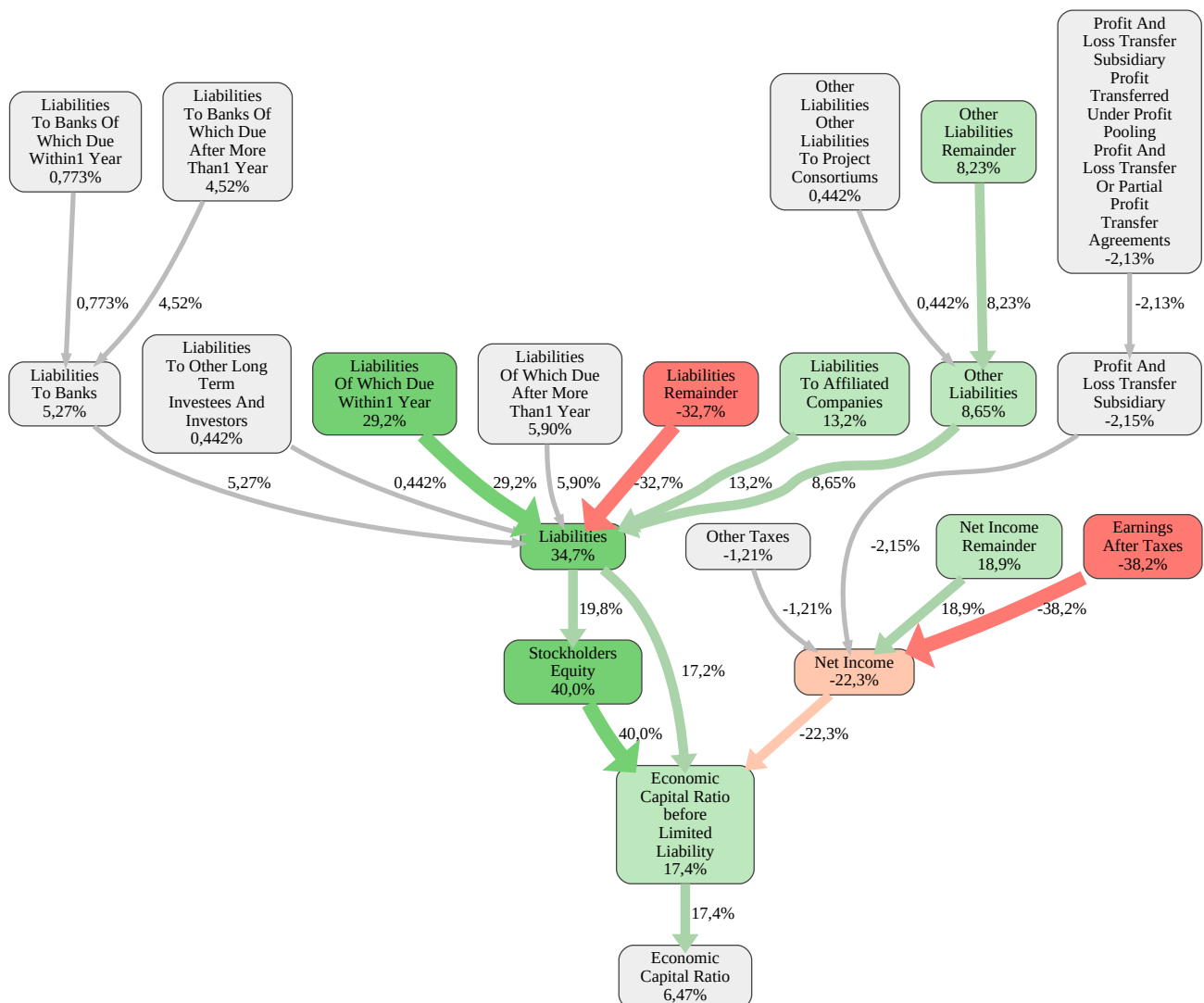

The relative strengths and weaknesses of Bauunternehmung Peter Igl GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 38% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 6,5% points above the market average of 260%.
