

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 588% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 1.040% points.

The company's Economic Capital Ratio, given in the ranking table, is 810%, being 547% points above the market average of 264%.
