

### Bauunternehmung Hermann GmbH Rank 44 of 116

The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Work In Progress Contracted Construction In Progress, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is 271%, being 7,8% points above the market average of 264%.
