

Fritz Meyer GmbH Bauunternehmung Rank 37 of 116

The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 275%, being 12% points above the market average of 264%.
