

# Reuter Bauunternehmen GmbH Rank 81 of 116

The relative strengths and weaknesses of Reuter Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Reuter Bauunternehmen GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Reuter Bauunternehmen GmbH is the variable Other Liabilities, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 237%, being 27% points below the market average of 264%.
