The greatest weakness of Bautzener Wohnungsbaugesellschaft mbH is the variable Tangible Fixed Assets, reducing the Economic Capital Ratio by 37% points.

The company's Economic Capital Ratio, given in the ranking table, is 279%, being 15% points above the market average of 264%.
