

#### Cadolto Modulbau GmbH Rank 78 of 116

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 81% points.

The company's Economic Capital Ratio, given in the ranking table, is 242%, being 16% points below the market average of 258%.
