

### Ortwin Goldbeck Holding SE Rank 103 of 113

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Receivables From Affiliated Companies, increasing the Economic Capital Ratio by 17% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Liabilities To Affiliated Companies, reducing the Economic Capital Ratio by 123% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 139% points below the market average of 243%.
