



The relative strengths and weaknesses of Ruben Schäfer Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Liabilities Of Which Due Within 1 Year, reducing the Economic Capital Ratio by 2.395% points.

The company's Economic Capital Ratio, given in the ranking table, is 251%, being 7,4% points above the market average of 243%.
