



The relative strengths and weaknesses of Bauunternehmung Peter Igl GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 16% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 150% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 176% points below the market average of 243%.
