

Matthias Ruppert Bauunternehmen

The relative strengths and weaknesses of Matthias Ruppert Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Matthias Ruppert Bauunternehmen GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 45% points. The greatest weakness of Matthias Ruppert Bauunternehmen GmbH is the variable Inventories Remainder, reducing the Economic Capital Ratio by 49% points.

The company's Economic Capital Ratio, given in the ranking table, is 301%, being 57% points above the market average of 243%.
