

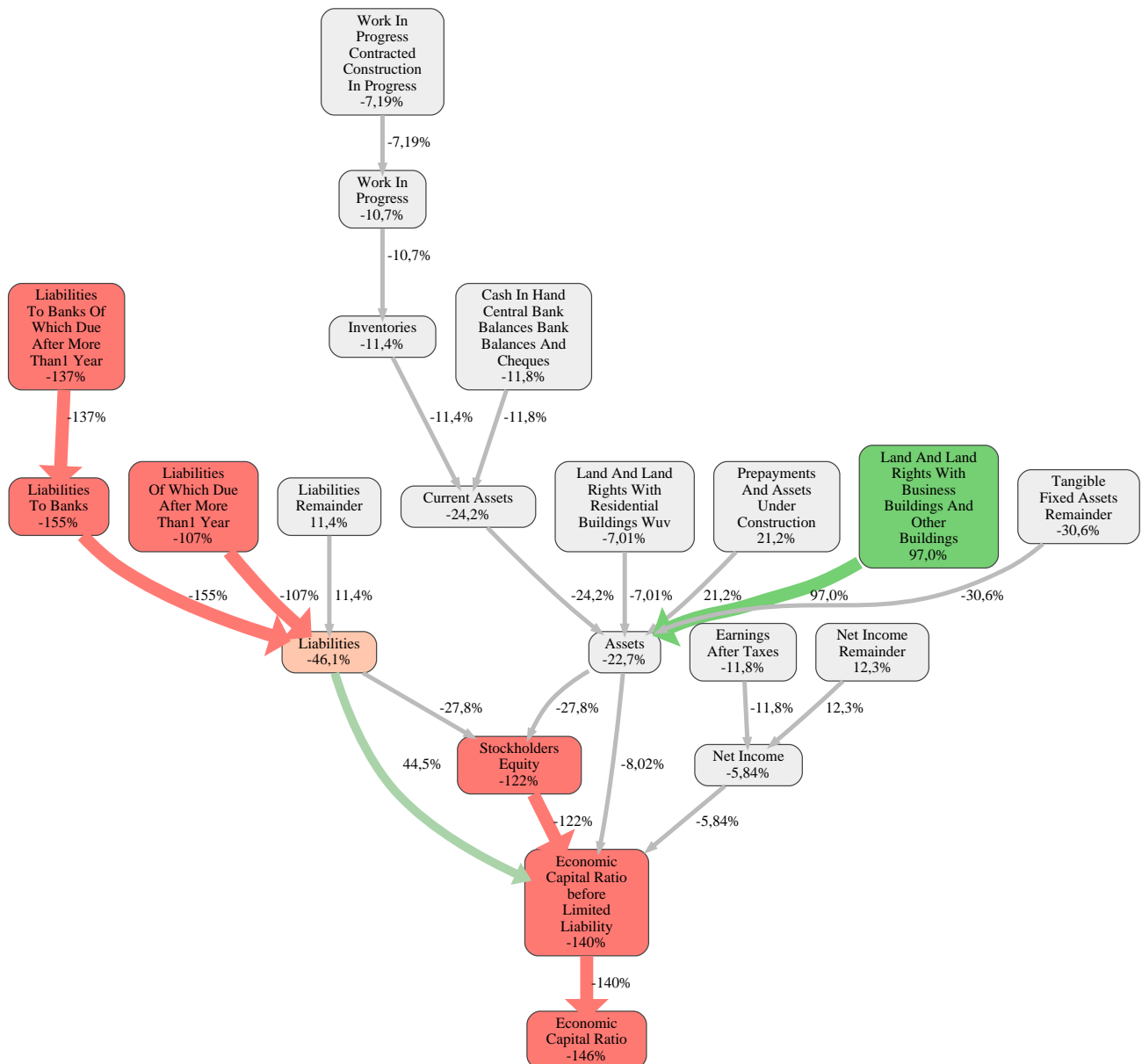

The relative strengths and weaknesses of Hanova Gewerbe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Land And Land Rights With Business Buildings And Other Buildings, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 155% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 146% points below the market average of 243%.
