

Goldbeck GmbH Rank 91 of 109

The relative strengths and weaknesses of Goldbeck GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Goldbeck GmbH is the variable Net Income, reducing the Economic Capital Ratio by 458% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 583% points below the market average of 737%.
