

#### Fuchs Bau GmbH Rank 64 of 109

The relative strengths and weaknesses of Fuchs Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fuchs Bau GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Fuchs Bau GmbH is the variable Net Income, reducing the Economic Capital Ratio by 454% points.

The company's Economic Capital Ratio, given in the ranking table, is 251%, being 486% points below the market average of 737%.
