



The relative strengths and weaknesses of Weberhaus GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Net Income, reducing the Economic Capital Ratio by 443% points.

The company's Economic Capital Ratio, given in the ranking table, is 282%, being 455% points below the market average of 737%.
