

Arlt Bauunternehmen GmbH Rank 85 of 109

The relative strengths and weaknesses of Arlt Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arlt Bauunternehmen GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Arlt Bauunternehmen GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 412% points.

The company's Economic Capital Ratio, given in the ranking table, is 192%, being 546% points below the market average of 737%.
