

Hanova Wohnen GmbH Rank 55 of 109

The relative strengths and weaknesses of Hanova Wohnen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Wohnen GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of Hanova Wohnen GmbH is the variable Net Income, reducing the Economic Capital Ratio by 451% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 479% points below the market average of 737%.
