



The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 131% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Net Income Remainder, reducing the Economic Capital Ratio by 428% points.

The company's Economic Capital Ratio, given in the ranking table, is 303%, being 435% points below the market average of 737%.
