

#### Goldbeck GmbH Konzern Rank 96 of 109

The relative strengths and weaknesses of Goldbeck GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH Konzern compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Goldbeck GmbH Konzern is the variable Net Income Remainder, reducing the Economic Capital Ratio by 715% points.

The company's Economic Capital Ratio, given in the ranking table, is 129%, being 609% points below the market average of 737%.
