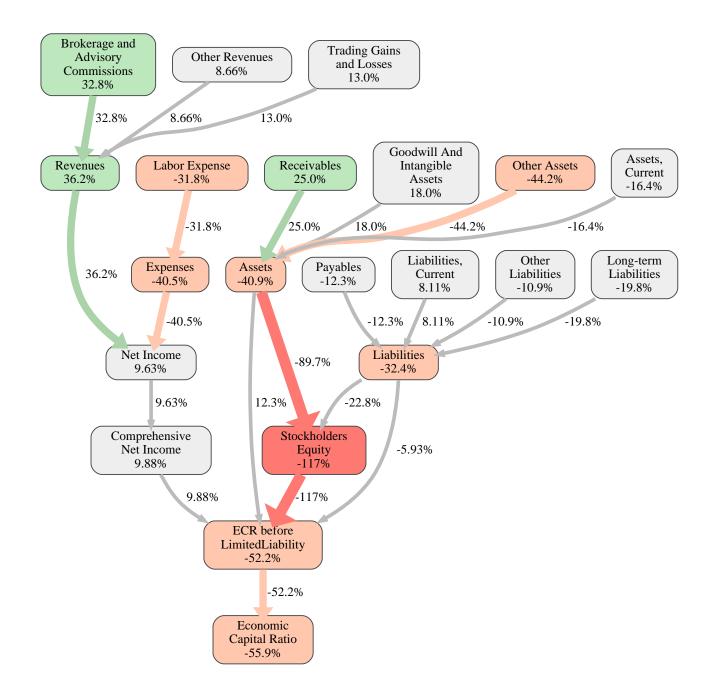

The greatest strength of GFI Group Inc compared to the market average is the variable Revenues, increasing the Economic Capital Ratio by 36% points. The greatest weakness of GFI Group Inc is the variable Stockholders Equity, reducing the Economic Capital Ratio by 117% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 56% points below the market average of 136%.
