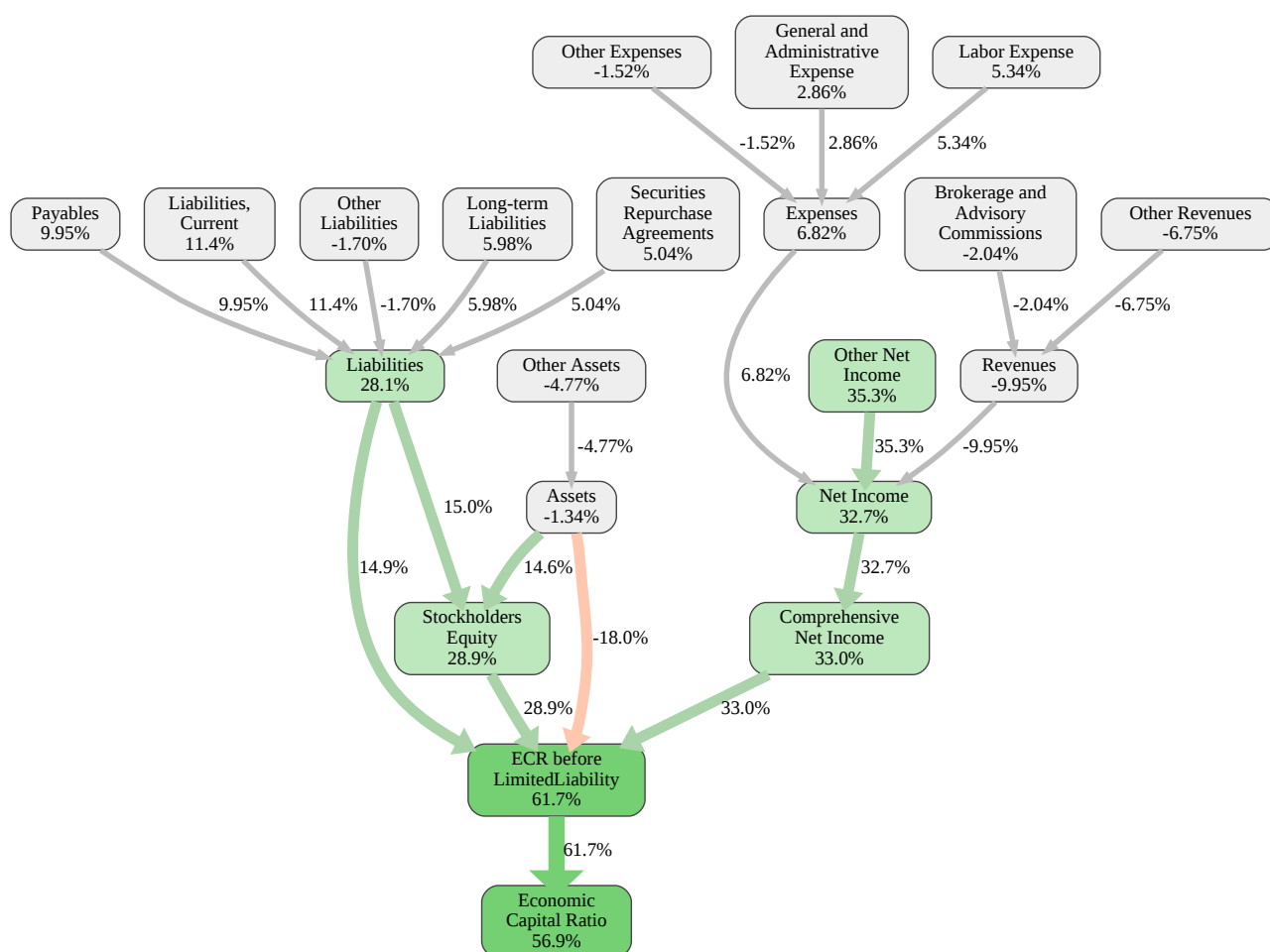




Frontier Balanced Fund Rank 14 of 103

The relative strengths and weaknesses of Frontier Balanced Fund are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Frontier Balanced Fund compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 35% points. The greatest weakness of Frontier Balanced Fund is the variable Revenues, reducing the Economic Capital Ratio by 10.0% points.

The company's Economic Capital Ratio, given in the ranking table, is 200%, being 57% points above the market average of 143%.
