

## Invesco Currencyshares Euro Trust Rank 28 of 79



The relative strengths and weaknesses of Invesco Currencyshares Euro Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Invesco Currencyshares Euro Trust compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Invesco Currencyshares Euro Trust is the variable Revenues, reducing the Economic Capital Ratio by 11% points.

The company's Economic Capital Ratio, given in the ranking table, is 186%, being 39% points above the market average of 147%.
