

The relative strengths and weaknesses of HPIL Holding are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HPIL Holding compared to the market average is the variable Assets, Noncurrent, increasing the Economic Capital Ratio by 77% points. The greatest weakness of HPIL Holding is the variable Comprehensive Net Income, reducing the Economic Capital Ratio by 98% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 29% points below the market average of 122%.
