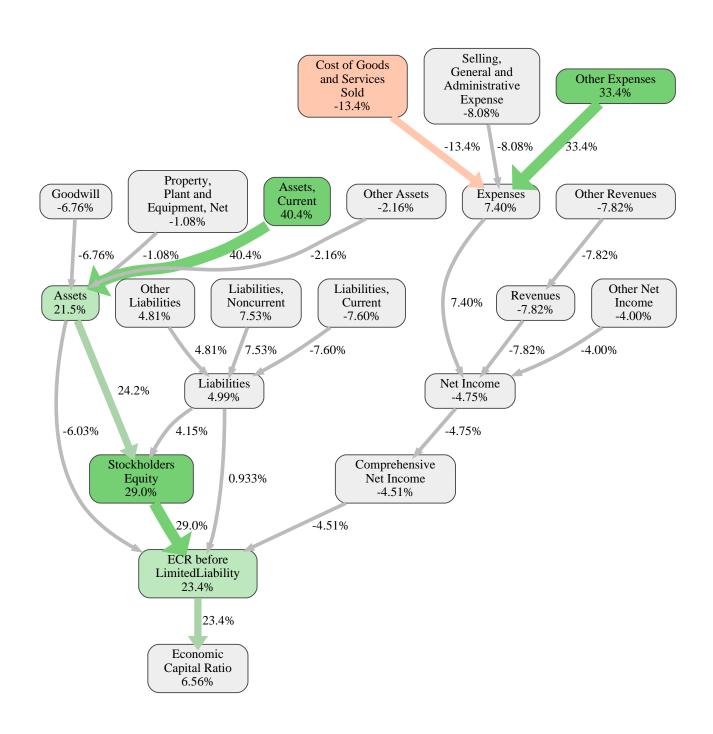

Proterra Inc Rank 30 of 69

The relative strengths and weaknesses of Proterra Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Proterra Inc compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Proterra Inc is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 13% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 6.6% points above the market average of 99%.
