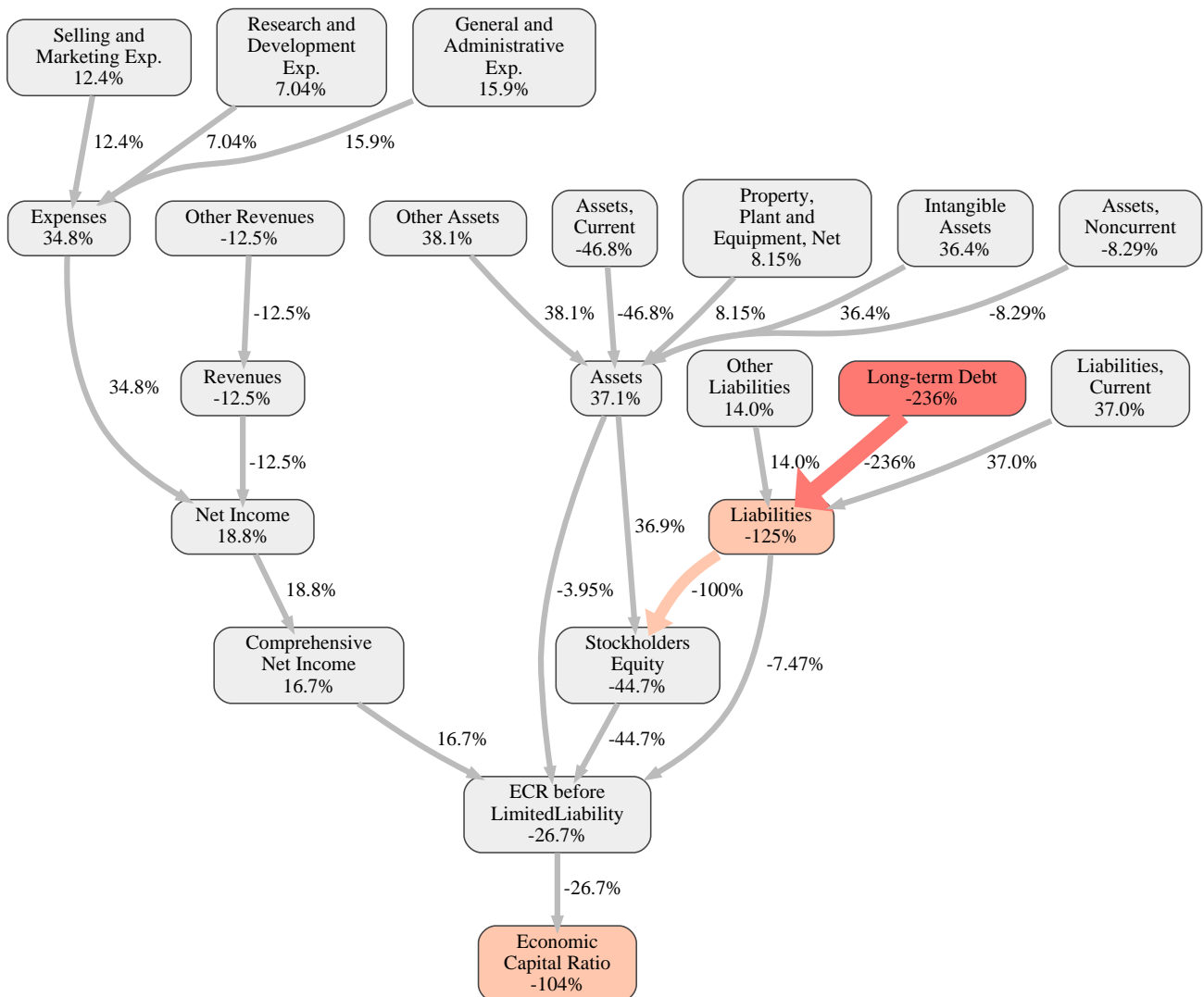

The relative strengths and weaknesses of SunGard are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SunGard compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 38% points. The greatest weakness of SunGard is the variable Long-term Debt, reducing the Economic Capital Ratio by 236% points.

The company's Economic Capital Ratio, given in the ranking table, is 248%, being 104% points below the market average of 352%.
