

### Dreßler Bau GmbH Rank 32 of 108

The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of Dreßler Bau GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 45% points.

The company's Economic Capital Ratio, given in the ranking table, is 195%, being 14% points above the market average of 181%.
