

Markgraf Familien

The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Markgraf Familien GmbH is the variable Earnings After Taxes Remainder, reducing the Economic Capital Ratio by 10,0% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 85% points above the market average of 181%.
