

Bauunternehmung Albert Weil

The relative strengths and weaknesses of Bauunternehmung Albert Weil Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Trade Payables Remainder, reducing the Economic Capital Ratio by 19% points.

The company's Economic Capital Ratio, given in the ranking table, is 207%, being 27% points above the market average of 181%.
