

SEH Engineering GmbH Rank 53 of 108

The relative strengths and weaknesses of SEH Engineering GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SEH Engineering GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 168% points. The greatest weakness of SEH Engineering GmbH is the variable Work In Progress Unfinished Goods Remainder, reducing the Economic Capital Ratio by 3.623% points.

The company's Economic Capital Ratio, given in the ranking table, is 176%, being 4,7% points below the market average of 181%.
