

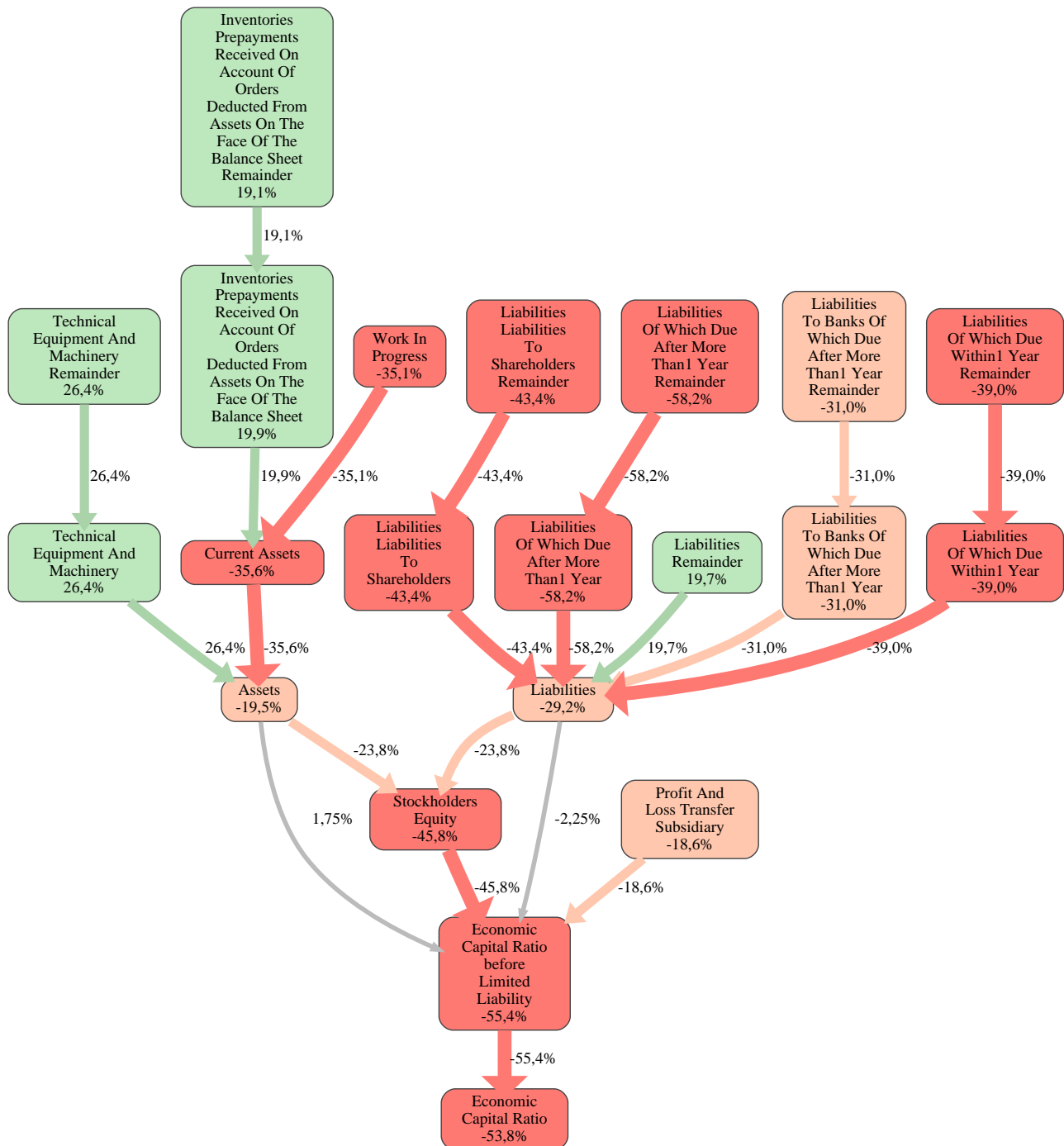

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Technical Equipment And Machinery Remainder, increasing the Economic Capital Ratio by 26% points. The greatest weakness of Hanova Services GmbH is the variable Liabilities Of Which Due After More Than 1 Year Remainder, reducing the Economic Capital Ratio by 58% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 54% points below the market average of 181%.
