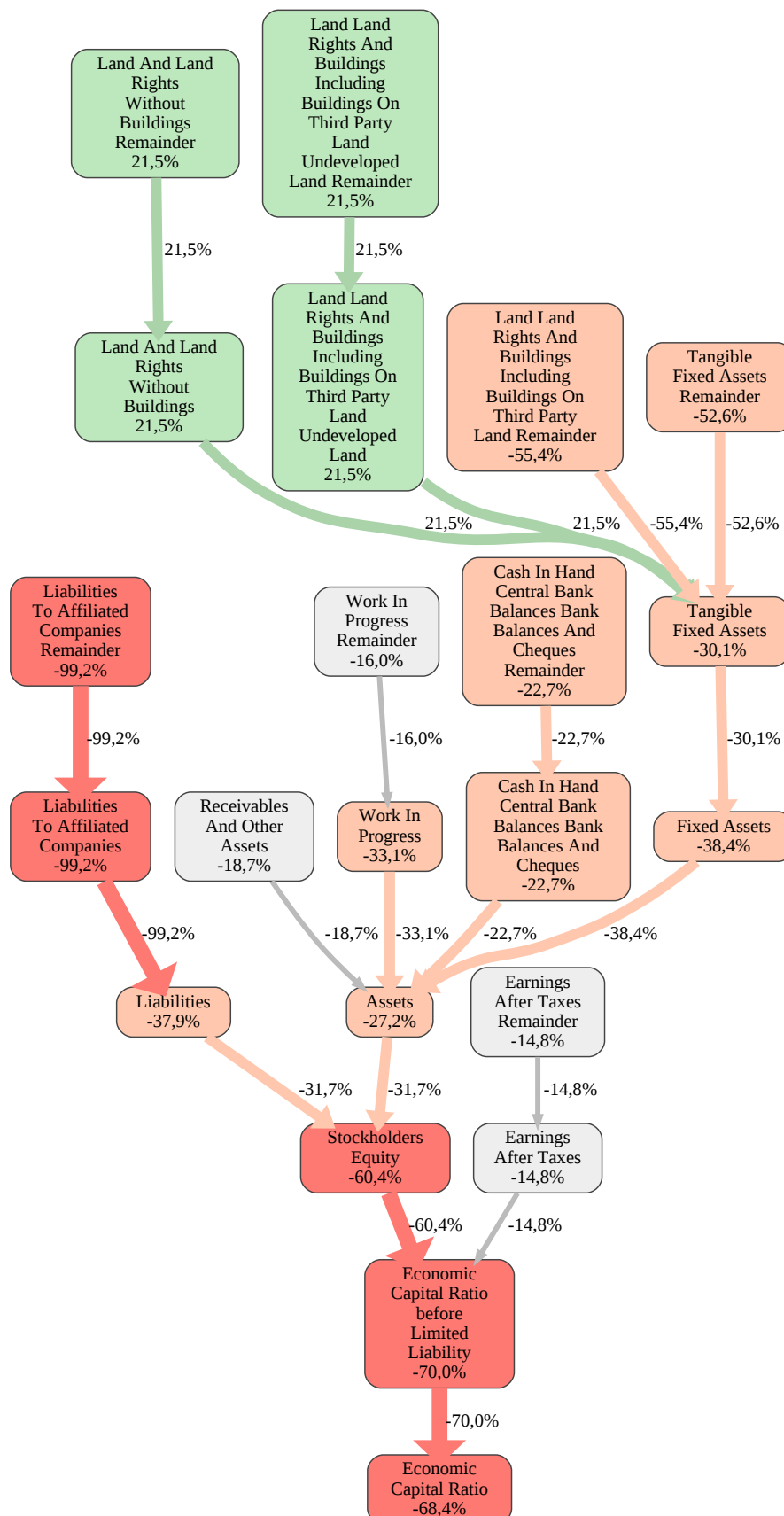




The relative strengths and weaknesses of Bonava Wohnbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Land Land Rights And Buildings Including Buildings On Third Party Land Undeveloped Land Remainder, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Liabilities To Affiliated Companies Remainder, reducing the Economic Capital Ratio by 99% points.

The company's Economic Capital Ratio, given in the ranking table, is 112%, being 68% points below the market average of 181%.
