



The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques Remainder, increasing the Economic Capital Ratio by 35% points. The greatest weakness of Bateg GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 142% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 29% points above the market average of 183%.
