

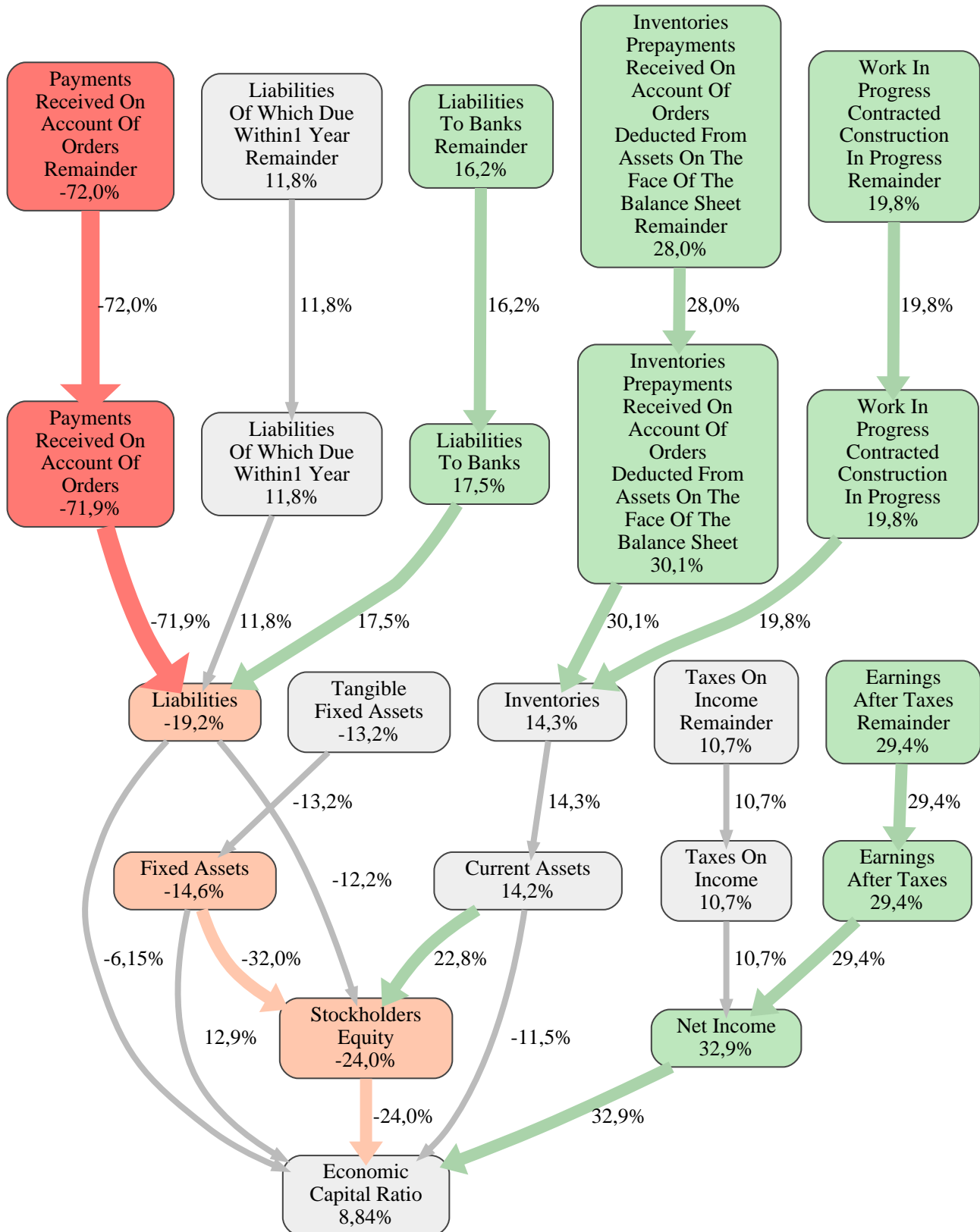

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 33% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 72% points.

The company's Economic Capital Ratio, given in the ranking table, is 191%, being 8,8% points above the market average of 183%.
