

Haas Fertigbau

Haas Fertigbau GmbH Rank 51 of 110

The relative strengths and weaknesses of Haas Fertigbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Haas Fertigbau GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Haas Fertigbau GmbH is the variable Trade Payables Remainder, reducing the Economic Capital Ratio by 17% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 4,8% points above the market average of 183%.
