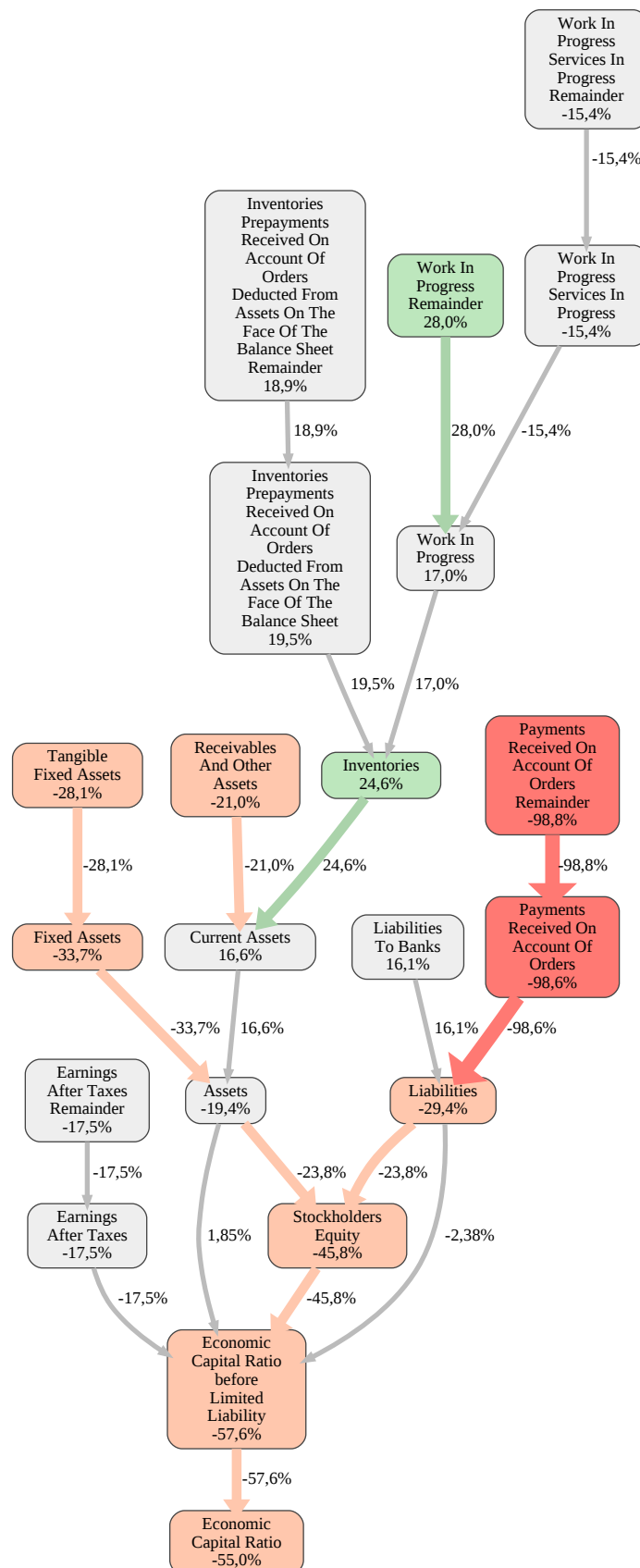




The relative strengths and weaknesses of GP Con GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GP Con GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 28% points. The greatest weakness of GP Con GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 99% points.

The company's Economic Capital Ratio, given in the ranking table, is 128%, being 55% points below the market average of 183%.
