

#### HBG Bau GmbH Rank 110 of 110

The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Shares In Affiliated Companies Remainder, increasing the Economic Capital Ratio by 40% points. The greatest weakness of HBG Bau GmbH is the variable Liabilities Of Which Due Within1 Year Remainder, reducing the Economic Capital Ratio by 93% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 71% points below the market average of 183%.
