

Rensch Haus GmbH Rank 29 of 110

The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year Remainder, increasing the Economic Capital Ratio by 12% points. The greatest weakness of Rensch Haus GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 26% points.

The company's Economic Capital Ratio, given in the ranking table, is 204%, being 21% points above the market average of 183%.
