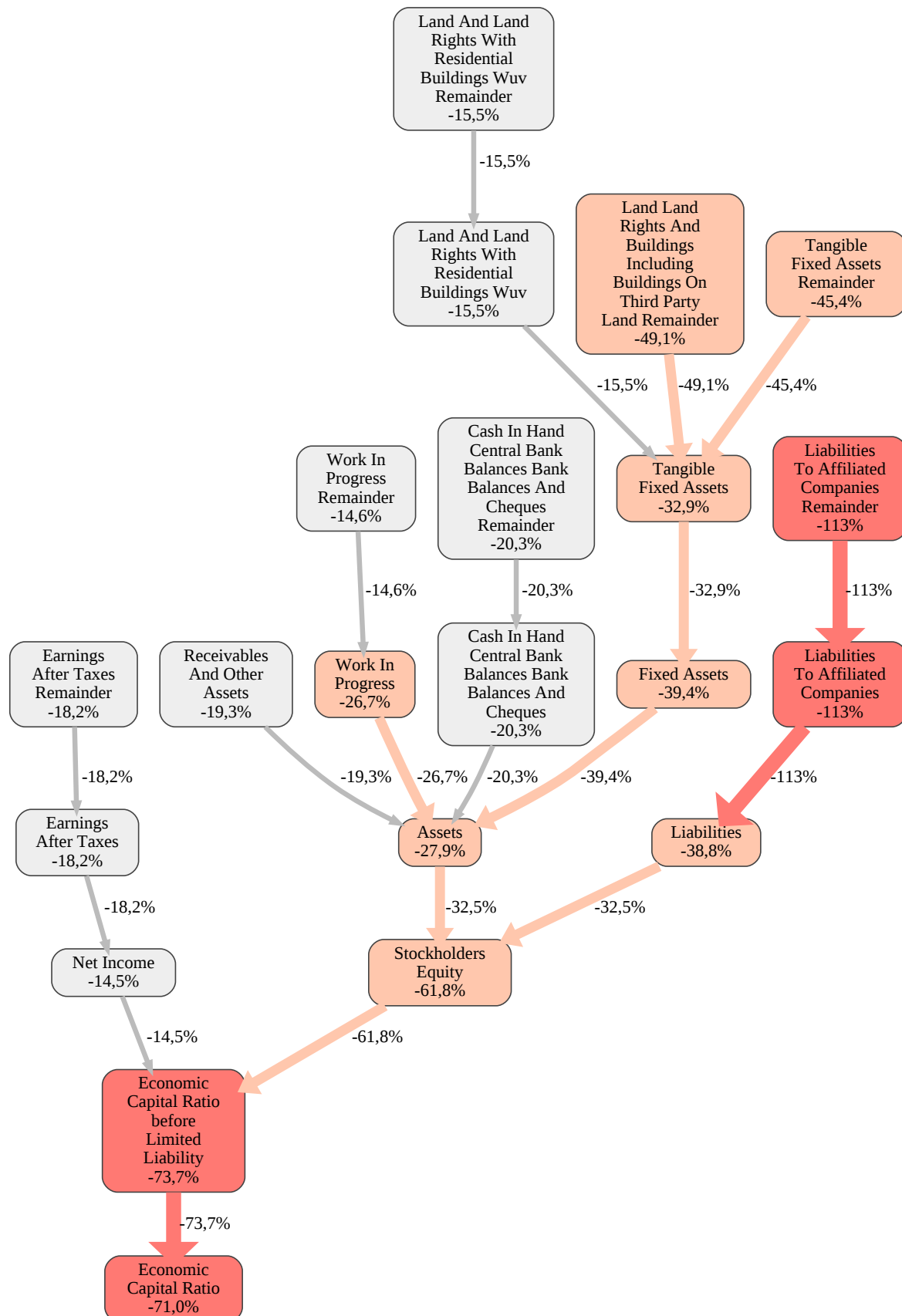




The relative strengths and weaknesses of Bonava Wohnbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 13% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Liabilities To Affiliated Companies Remainder, reducing the Economic Capital Ratio by 113% points.

The company's Economic Capital Ratio, given in the ranking table, is 112%, being 71% points below the market average of 183%.
