



The relative strengths and weaknesses of Schrobsdorff Bau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Bau Aktiengesellschaft compared to the market average is the variable Earnings After Taxes Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Schrobsdorff Bau Aktiengesellschaft is the variable Liabilities Of Which Due Within 1 Year Remainder, reducing the Economic Capital Ratio by 73% points.

The company's Economic Capital Ratio, given in the ranking table, is 236%, being 54% points above the market average of 182%.
