

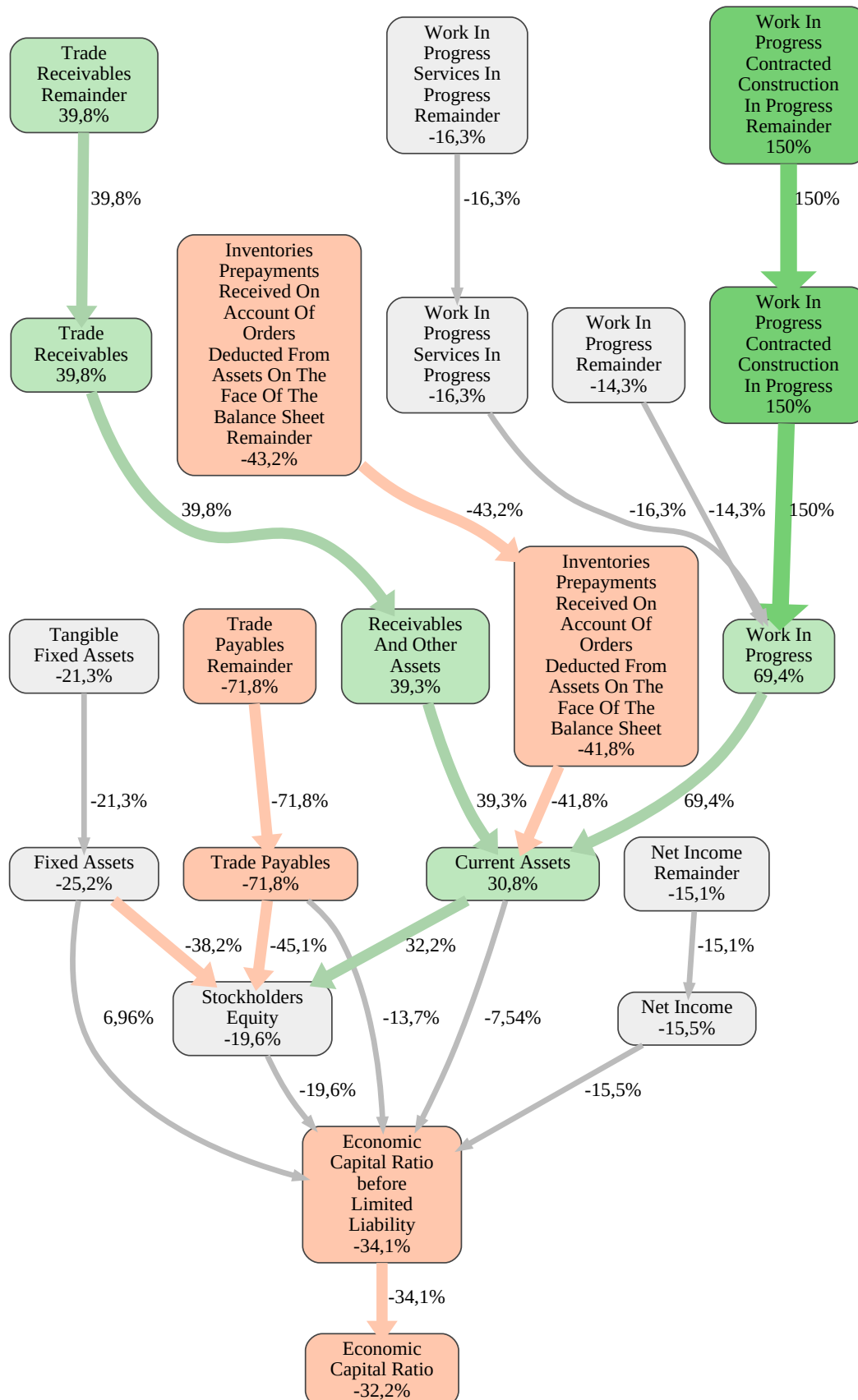

The relative strengths and weaknesses of Otto Mühlherr Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Work In Progress Contracted Construction In Progress Remainder, increasing the Economic Capital Ratio by 150% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Trade Payables Remainder, reducing the Economic Capital Ratio by 72% points.

The company's Economic Capital Ratio, given in the ranking table, is 150%, being 32% points below the market average of 182%.
