

Haas Fertigbau GmbH Rank 113 of 115

The relative strengths and weaknesses of Haas Fertigbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Haas Fertigbau GmbH compared to the market average is the variable Long Term Financial Assets Remainder, increasing the Economic Capital Ratio by 7,7% points. The greatest weakness of Haas Fertigbau GmbH is the variable Net Income, reducing the Economic Capital Ratio by 58% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 71% points below the market average of 182%.
