

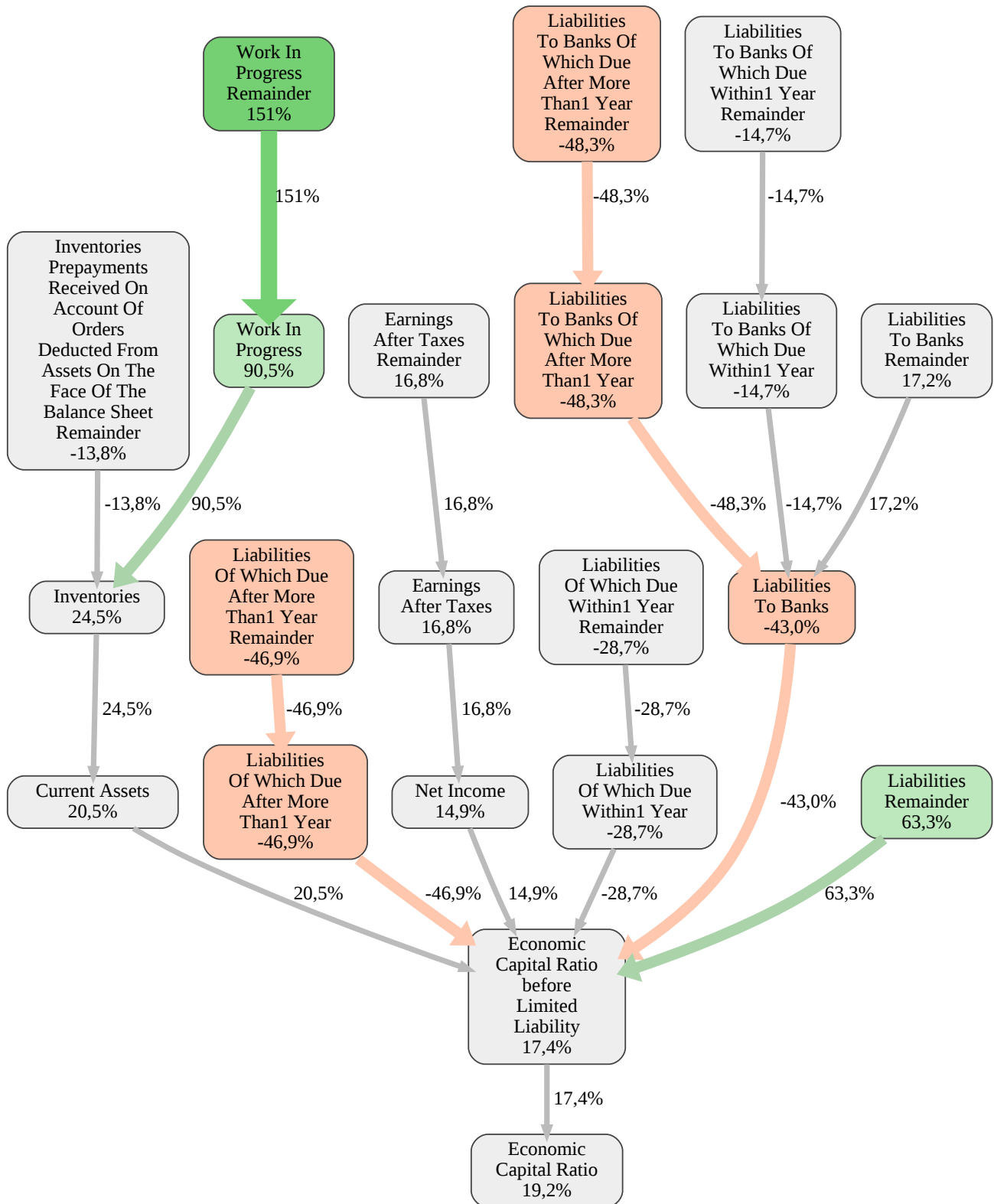

The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 151% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Liabilities To Banks Of Which Due After More Than 1 Year Remainder, reducing the Economic Capital Ratio by 48% points.

The company's Economic Capital Ratio, given in the ranking table, is 202%, being 19% points above the market average of 182%.
